- 1.A (U) THE SHARP STRATEGIC MANAGEMENT SYSTEM (SMS) IS A PERFORMANCE

MANAGEMENT TOOL AVAILABLE TO ALL ARMY ORGANIZATIONS AND COMPONENTS. SMS IS A WEB-BASED APPLICATION SECURED THROUGH CAC AUTHENTICATION THAT

MEETS ARMY NEEDS TO TRACK PERFORMANCE AND MISSION OBJECTIVES ON BOTH CLASSIFIED AND UNCLASSIFIED NETWORKS. ORGANIZATIONS DEFINE THEIR OBJECTIVES, STANDARDS, BRIEFING FORMATS, AND SMS PROVIDES PERFORMANCE

FEEDBACK AND TRACKING. SMS HAS THE ABILITY TO CONNECT TO AUTHORITATIVE

DATA SOURCES AND DECREASE ORGANIZATIONAL RESOURCES DEVOTED TO DATA GATHERING TO FOCUS ON ANALYSIS. IMPLEMENTATION OF THE SEXUAL HARASSMENT TRACKER ADDRESSES THE GAPS IDENTIFIED BY THE FORT HOOD

2. (U) MISSION. EFFECTIVE 1 MAR 2023, SHARP PROFESSIONALS WILL ENTER

ALL ANONYMOUS AND FORMAL SEXUAL HARASSMENT COMPLAINTS INTO BOTH THE INTEGRATED CASE REPORTING SYSTEM (ICRS) AND THE SMS SEXUAL HARASSMENT

COMPLAINT TRACKING TOOL TO ENSURE POLICY COMPLIANCE, IMPROVE EXECUTION

OF REQUIRED RESPONSE ACTIONS, AND TRACK THE AGING LIFE-CYCLE OF COMPLAINTS.

3. (U) EXECUTION:

3.A. (U) INTENT. TO ENSURE COMPLIANCE WITH ALL REGULATORY
REQUIREMENTS RELATED TO THE INVESTIGATION AND HANDLING OF SEXUAL
HARASSMENT COMPLAINTS, LEAD SARCS AND SUPPORTING AGENCIES WILL
IMPLEMENT THE USE OF THE SMS SEXUAL HARASSMENT COMPLAINT TRACKER TOOL

AT THEIR INSTALLATIONS IN ORDER TO MAINTAIN PROPER OVERSIGHT OF ALL FORMAL AND ANONYMOUS SEXUAL HARASSMENT COMPLAINTS AND ENFORCE COMMANDERS ACCOUNTABLITY FOR THE REQUIRMENTS IN THE COMPLAINT PROCESS.

3.A.1. (U) KEY TASKS.

- 3.A.1.A. (U) SENIOR COMMANDERS WILL USE THE SMS SEXUAL HARASSMENT COMPLAINT TRACKER AT QUARTERLY SEXUAL ASSAULT RESPONSE TEAM (Q-SART) MEETINGS FOR REVIEW OF COMPLIANCE WITH REQUIRED TIMELINES AND CASE CHARATERISTICS/DISPOSITION TRENDS. SENIOR COMMANDERS WILL CONSULT WITH THEIR SUPPORTING STAFF JUDGE ADVOCATE TO ENSURE THAT CASE DISPOSITION INFORMATION IS CORRECT PRIOR TO THE MEETING.
- 3.A.1.B. (U) SENIOR COMMANDERS WILL ENSURE SARCS COMPLETE TIMELY AND

ACCURATE ENTRY OF DATA TO TRACK THE LIFE-CYCLE OF SEXUAL HARASSMENT COMPLAINTS AND ENFORCE COMPLIANCE WITHIN REQUIRED TIMELINES.

- 3.A.2. (U) ENDSTATE. SENIOR COMMANDERS UTILIZE THE SMS SEXUAL HARASSMENT TRACKER TOOL TO IMPROVE THEIR ABILITY TO TRACK THE AGING LIFE-CYCLE OF CASES AND REVIEW CONSISTENCY OF DISPOSITION ACTIONS.
- 3.B. (U) CONCEPT OF OPERATION.
- 3.B.1. (U) SENIOR COMMANDERS WILL UTILIZE DATA IN THE SMS SEXUAL HARASSMENT TRACKER TO INFORM THE Q-SART. COMMANDERS WILL REVIEW DATA,

FOCUSING ON QUALITY CONTROL, COMPLIANCE WITH THE TIMELINE REQUIREMENTS
OUTLINED IN POLICY, AND DISPOSITION DATA.

- 3.C. (U) TASKS TO ARMY STAFF, SUBORDINATE UNITS AND REQUESTS FOR SUPPORT.
- 3.C.1. (U) HQDA, DCS, G-1, ARMY RESILIENCE DIRECTORATE.
- 3.C.1.A. (U) REVIEW REQUESTS, APPROVE, AND MONITOR ALL SARC, LEAD SARC, AND SHARP PROGRAM MANAGER ACCESS TO SMS.

- 3.C.1.B. (U) DEVELOP AND DELIVER IMPLEMENTATION TRAINING FOR ALL REQUIRED PERSONNEL REGARDING THE USE OF THE SMS SEXUAL HARASSMENT COMPLAINT TRACKER.

- 3.C.1.E. (U) ASSIST ARMY SMS USERS WITH SMS SEXUAL HARASSMENT COMPLAINT TRACKER ISSUES AND DATA ENTRY.
- 3.C.1.F. (U) PROVIDE SMS CONTRACTOR TO ALL SHARP CAREER COURSE CLASSES TO DELIVER INSTRUCTION ON THE SMS SEXUAL HARASSMENT COMPLAINT

TRACKING TOOL. TRAINING WILL BE PROVIDED BY THE SMS PERSONNEL AS COORDINATED BETWEEN HQDA ARD AND THE SHARP ACADEMY. HQDA SHARP DATA MANAGEMENT BRANCH WILL TRACK TRAINING COMPLETION. A SMS SEXUAL HARASSMENT TRACKER TRAINING VIDEO WILL BE AVAILABLE AS SUPPLEMENTAL INFORMATION BUT WILL NOT REPLACE MANDATORY TRAINING.

- 3.C.2. (U) COMMANDERS, ARMY COMMANDS (ACOM), ARMY SERVICE SUPPORT COMMANDS (ASCC), DIRECT REPORTING UNITS (DRU) AND UNITED STATES ARMY RESERVE COMMAND (USARC).
- 3.C.2.A. (U) ENSURE SHARP PROGRAM MANAGERS REVIEW MONTHLY SMS SEXUAL
- HARASSMENT COMPLAINT TRACKER QUALITY CONTROL (QC) REPORTS PROVIDED BY
- THE HQDA SHARP PROGRAM OFFICE (NLT 8TH OF THE MONTH) AND ENSURE ERROR
- CORRECTION AND RECONCILIATION OF MISSING DATA.
- 3.C.2.B. (U) ASSIST SUBORDINATE LEAD SARCS AND SENIOR COMMANDERS IN THE REVIEW OF ACTIONS TAKEN TO RESOLVE ALL SMS SEXUAL HARASSMENT COMPLAINT TRACKER DATA ERRORS AND THE RECONCILIATION OF MISSING DATA PRIOR TO THE Q-SART.
- 3.C.2.C. (U) ENSURE THAT ALL SHARP PROFESSIONALS' PERFORMANCE EVALUATIONS INCLUDE "ENSURE THE ACCURACY AND TIMELY ENTRY OF ALL DATA
- IN BOTH ICRS AND THE SMS SEXUAL HARASSMENT COMPLAINT TRACKER" AND ARE
- HELD ACCOUNTABLE FOR THE DATA QUALITY.
- 3.C.3. (U) SENIOR COMMANDERS.
- 3.C.3.A. (U) ENSURE EACH COMPLAINT OF SEXUAL HARASSMENT IS ENTERED INTO THE SMS SEXUAL HARASSMENT COMPLAINT TRACKER SUCH THAT EACH RECORD
- HAS ONLY ONE UNIQUE CASE NUMBER.
- 3.C.3.B. (U) REVIEW ALL SEXUAL HARASSMENT COMPLAINTS AT THE Q-SART UTILIZING THE SMS SEXUAL HARASSMENT TRACKING TOOL TO ENSURE COMPLIANCE
- WITH REQUIRED COMPLAINT TIMELINES AND REVIEW SYSTEMIC ISSUES WITH OR WITHIN THE COMPLAINT PROCESS.
